



Local ADAMHS Boards: Benefiting Communities for 40 Years

There are 46 local Alcohol, Drug Addiction and Mental Health Services (ADAMHS) Boards, 4 Alcohol and Drug Addiction Services (ADAS) Boards and 4 Community Mental Health (CMH) Boards representing Ohio's 88 counties. These County Boards are made up of volunteer members from the community and given the statutory authority to plan, fund, monitor and evaluate publicly funded mental health and recovery services. The strength of the local Boards lie in community and family involvement - local citizens evaluating needs and planning services for our community's most vulnerable population. Who better to render decisions on local mental health and recovery services than dedicated members of our local community?

Celebrating 40 Years of Service to the Tri-County Community

The Tri-County Board of Recovery and Mental Health Services, along with other ADAMHS Boards from across Ohio, celebrated their 40th Anniversary in Columbus on January 30, 2008. The event, hosted by the Ohio Association of County Behavioral Health Authorities, highlighted the history of the state and local behavioral health system as well as honored local Board Members for their contribution and commitment to our system. Tri-County Board Chairperson, Wayne Willcox, was among those honored at the celebration.

A bit of local history...

On July 17, 1967, the Ohio Community Mental Health and Mental Retardation act (HB 648) was passed and provisions were made for local input and control of the services provided. On November 20, 1967, Miami County Commissioners named six members of the required nine to serve on the local 648 Mental Health and Mental Retardation Board. After the Board was organized and functioning, it was mutually agreed among the County Commissioners of Miami, Darke and Shelby Counties to expand the Board area to include all three Counties. This would allow the area of jurisdiction of the Board to correspond with the Tri-County Catchment Area designated in the State Plan.

Official action was taken by the Darke County Commis-

sioners on September 30, 1968 in the appointment of members to the Board from Darke County. This was followed on October 2, 1968 by two appointments by the Shelby County Commissioners. At the regular Board meeting on October 16, 1968, with representation from all three counties, the Board became the Tri-County Board of Mental Health and Mental Retardation.

In 1989, HB 317, the Alcohol and Drug Addiction Services Act, created the Ohio Department of Alcohol and Drug Addiction Services and added substance abuse prevention, treatment and support services under the authority of the local Boards — creating local ADAMHS Board.

Board & System News Darke County IHBT Grant

The Darke County Mental Health Clinic was awarded funding for certification to provide Intensive Home Based Treatment (IHBT) to children and their families that are at risk for out-of-home placement in Darke County.

The IHBT Program will allow the DCMHC to offer Intensive Home Based Treatment to children that display an array of dangerous behaviors that cannot be effectively and appropriately treated with traditional community-based intervention strategies. These children are diagnosed with severe emotional disturbances (SED) and are proven to be at high risk for out-of-home placement. The Darke County IHBT Program will

operate through the Darke County Intersystem Diversion Team (IDT) and include 6-12 weeks of intensive treatment. As part of the treatment program, a child and family wrap around plan will be developed with input from the family, IDT Core Team and the IHBT Team that will identify all service providers working with the family. The IHBT Program and wrap around services will:

- provide parents with the skills necessary to maintain child safety and preserve the family in a home environment;
- ▶ provide services that will allow the child to remain with the family during treatment and avoid long-

term placement; and

provide intersystem service collaboration to assure appropriate and effective treatment.

Since the establishment of the IHBT program in January 2008, the Darke County Mental Health Clinic has identified the lead therapist and primary CPSP for the program as well as identified 8 families that may be appropriate referrals for IHBT services.

State Budget News and System Changes

On Thursday, January 31, 2008, Ohio Governor Ted Strickland announced the closing of two State Hospital campuses in Ohio — one being the facility utilized by our Board area, Twin Valley Behavioral Healthcare located in Dayton. The hospitals will close on July 1, 2008.

In addition to the closure of the State Hospital campuses, Strickland unveiled budget cuts and other changes to balance the \$52.3 billion budget, which runs July 1, 2007 to June 30, 2009. Among those reductions were targeted reductions to the Ohio Department of Mental Health and the Ohio Department of alcohol and Drug Addiction Services.

An economic slow down was

sited for the budget squeeze and reductions made to the State mental health system. Jim Ignelzi, Deputy Director of the Ohio Department of Mental Health, said the Twin Valley Behavioral Healthcare campus in Dayton was targeted because of the age of the facility and the fact that there are additional State psychiatric hospitals located in Cincinnati, Columbus and Toledo. The Dayton campus, located on Wayne Avenue, has been in existence for more than 150 years. The facility employs 200 staff members and operates on a \$10 million a year budget. The outpatient program of Twin Valley will continue to be open.

Our Board area, consisting of Darke, Miami and Shelby

Counties, has been reassigned to the Toledo campus of the State Hospital. The Tri-County Board is aware that the reassignment will create additional stressors on consumers, families and law enforcement due to transportation issues. We are currently exploring ways to reduce the impact of the Dayton campus hospital closure and enhance local capacity.

The other mental health hospital to close in Ohio is located in Cambridge, about 100 miles east of Columbus. It too is one of the older facilities and is located in close proximity to a newer facility in Athens.

Tri-County CIT Academy

This intensive 4-day training will provide law enforcement with the knowledge and skills needed to respond effectively to a crisis incident involving a mentally ill individual.
